GENERAL DATA PROTECTION REGULATION (GDPR).

Dear Club Member

On the 28th May 2018 the GDPR supersedes the Data Protection Act 1998. Cambridge Accordion Club will comply with the new regulation. The club will therefore inform members of the procedures to be adopted and will ensure that every effort will be made to protect personal information held by the club. The following is extracted from the regulation and summarises the club's response and its commitments. CAC takes the issue of your personal information extremely seriously and we promise that we will not pass your details to any third parties outside of CAC.

- It is necessary for the club to have the expressed consent to hold each member's details on paper and electronically. To comply with this, when a person applies for membership or renews his/her annual membership, that person will be asked to sign the application or renewal form which will then give their consent to allow CAC to hold their records on file for the duration of their membership.
- If a member leaves or resigns from the club, CAC will ensure that all relating paper records are shredded and electronic links deleted.
- All personal data will be held by the Club Secretary and communication to members will be confined to CAC business.
- All emails sent by CAC will be written as a "Blind Carbon Copy" (Bcc).
- If CAC discovers a data breach which is likely to result in a risk to the rights and freedom of individuals (eg any data that could imply discrimination, damage to reputation, financial loss, loss of confidentiality or any other significant economic or social disadvantage), the CAC must report this to the Information Commissioner's Office.
